

## **Privacy Policy**

### **Our Commitment to Privacy**

Chicago Limousine, Inc. (Chicago Limo) is committed to protecting your privacy. Chicago limousine protects your online information in the same way Chicago limo protects its passengers information obtained through telephone reservations. Protecting the information you provide Chicago limo during a visit to Chicago limo's website ("AChicagoLimousine.com") is something that Chicago limo takes very seriously. Chicago limo has developed and adheres to this Privacy Policy, which discloses Chicago limo's online information practices, including the information that Chicago limo collects and how Chicago limo uses that information. By using this website, you are accepting the privacy practices set forth in this Privacy Policy.

#### Information Required to Make Reservations:

When you make an online travel reservation using Chicago Limo.com, Chicago limo will ask for the following

information ("personally identifiable information", or "PII") from you:

- Your name
- Your address
- Credit/Debit Card number, cardholder name and expiration date
- Billing address
- Your telephone/fax number
- Travel companion names, and their addresses and telephone/fax numbers

This information is necessary to process your request.

### **Use of your Personal Information**

Information collected at AChicagolimousine.com, including your PII, may be used as follows:

- Create a Member Account. When you register to become a member of Chicago limo, Chicago limo uses your PII to create your member account.
- Plan and Purchase Travel. Information collected when you complete a traveler profile and/or the profiles of those traveling with you is used to confirm and process your travel reservation(s). As such, Chicago limo only discloses your PII to those service providers that you decide to make arrangements with through AChicagoLimousine.com.
- Send E-mail Notifications for Special Promotions. As a Chicago Limo Account member, if you have not opted-out to receive specific information from Chicago limo, Chicago limo may send you e-mails about special promotions, so a valid e-mail must be presented. Chicago limo only wants you to receive e-mail regarding special promotions and offers that you want to receive. As such, all of Chicago limo's e-mail contains clear information telling you how to unsubscribe, and Chicago limo will honor all such requests as soon as practicable.
- Respond to your Questions, Comments, or Suggestions. Chicago limo may use your e-mail address, mailing address, fax number or telephone number to respond when you submit a question, comment, or suggestion, or if you contact Chicago limo to request assistance.

### **Sharing Your Personal Information**

Chicago limo may provide your PII to third parties in the following circumstances:

- Affiliates and Third Parties. Chicago limo may share PII and other information collected at AChicagoLimousine.com with its subsidiaries, Affiliates. For travel arrangements, if you do not want your PII used for this purpose, you must notify Chicago limo by a written notice directing that your PII not be used or shared for this purpose, mailed postage prepaid to: Chicago limo, Inc., 5461 N. East River Rd, Suite: 407, Chicago, IL. 60656.
- Other Disclosure Obligations. Chicago limo may disclose your PII if required to do so by law, court order, as requested by other government or law enforcement authority, to enforce, or in the good faith belief that disclosure is otherwise necessary or advisable including, without limitation, to protect Chicago limo's rights or properties when Chicago limo has reason to believe that disclosing your PII is necessary to identify, contact or bring legal action against someone who

may be causing interference with Chicago limo's rights or properties, whether intentionally or otherwise, or when anyone else could be harmed by such activities. It may also be necessary for Chicago limo to provide member information to third parties, such as credit card companies, for the purpose of resolving disputes that arise in the normal course of business. Finally, in the event Chicago limo were to sell its business, any PII collected at Chicago limo.com would likely be one of the transferred assets.

### **Protecting Your Personal Information**

In order to safeguard the PII you have provided to Chicago limo through Chicago limo.com, Chicago limo has instituted appropriate physical and electronic measures to keep information electronically stored in its systems protected from unauthorized access. Chicago limo's systems are configured with industry-standard firewalls, systems designed to prevent unauthorized access. Of course, you are solely responsible for maintaining the secrecy of your password and any account information. Please be careful, responsible, and alert with this information, especially when you are online.

### **Credit Card Security**

For your protection, Chicago limo will not accept any credit card numbers from browsers not supporting SSL. When your credit card number is entered and submitted, SSL encodes and transmits it in a format that prevents data theft. Once Chicago limos secure server receives your encoded number, your credit card number will not be transmitted by Chicago limo over the internet again.

### **Links to Other Websites**

There are several places throughout AChicagoLimousine.com that may link you to other websites that do not operate under Chicago limo's information privacy policy, even though in some instances Chicago limo may brand another site with AChicagoLimousine.com look and feel or frame its website with AChicago Limousine.com. When you click through to these websites, Chicago limo's privacy policy no longer applies. Chicago limo recommends that you examine the privacy statements and policies for all third-party websites to understand their policies and procedures for collecting, using, and disclosing your PII.

### **Updating Your Personal Information**

Chicago limo believes that it is especially important for you to have the ability to update and change your PII so that you can help ensure that you receive information relating to the products or services purchased by you at AChicagoLimousine.com in a timely fashion. Accordingly, the My Account area of AChicagoLimousine.com allows you to view and change your PII. You may update or correct names, telephone numbers, contact information, and update your travel preferences. In addition, the "My Account" area permits you to change your account settings. For example, you could subscribe or unsubscribe to "Special E-mail Offers" or opt to receive e-mail notifications in the event that you had previously decided not to do so.

### **Chicago limo's Commitment to Children's Privacy**

Chicago limo does not collect any PII from a person actually known by Chicago limo to be under the age of 13. If you are under the age of 13, please do not provide PII of any kind whatsoever to Chicago limo online, through AChicagoLimousine.com or otherwise. No part of AChicagoLimo.com is directed to children, and no part of AChicagoLimousine.com is structured to attract anyone under the age of 13.
